### **The festival of the theatres of disabled people 'BEGASAS'**

#### REGULATIONS

##### I. GENERAL PROVISIONS

1. Disabled Theatre Festival is a festival-competition of disabled theater troupes;
2. Festival organizers - Lithuanian Association of People with Disabilities;
3. The festival's target group is the community of disabled people, artists and academic youth.

##### II. OBJECTIVES AND TASKS OF THE FESTIVAL

4. The objectives of the festival are following:
  - 4.1. To encourage people with disabilities to reveal their artistic abilities, way of thinking, creative powers;
  - 4.2. To create suitable conditions for the artistic self-expression of disabled people and to raise qualitative criteria;
  - 4.3. To show the society the ability of people with disabilities to create in a professional artistic environment;
  - 4.4. To involve people with disabilities in the international life of the theatre;

##### III. FESTIVAL ORGANIZATION

5. Tasks of the organizers:
  - 5.1. To prepare regulations and applications for participation in the festival;
  - 5.2. To prepare the program of the festival;
  - 5.3. To select festival participants, professional presenters and an international jury;
  - 5.4. To invite festival's guests of honor;
  - 5.5. To provide various information about the festival;
  - 5.6. To inform the media about the festival.

#### IV. FESTIVAL PARTICIPANTS

6. Participants of the festival may be all the disabled and artistic groups from any part of Lithuania that wish to participate;
- 6.1 Participants will be selected through a competition;
- 6.2 Those who wish to participate in the competition need to fill in the application form (Appendix No. 1) and submit the video material of the filmed performance until 17th of 2020 and email to [sniegamuza@gmail.com](mailto:sniegamuza@gmail.com) or [vitalijliubota@gmail.com](mailto:vitalijliubota@gmail.com) mobile +37068319477
- 6.3 Performances of the participants are prepared and presented by disabled people together with professionals in the field;
- 6.4 Disabled people must make 50% of members of the group (artistic groups participating in the festival must submit a list of participants together with the application);
- 6.5 The duration of each performance prepared by the group participating in the festival is from 15 to 60 minutes.

#### V. FESTIVAL VENUE, DATE AND FORM

The festival takes place from May 28th to June 1st.  
On ZOOM platform and FB account of Lithuanian Association of People with Disabilities every day at 6 p.m. 2 or 3 performances (performances from different countries) will be shown.  
At 7 p.m. after the end of performances there will be an open discussion, evaluation, recommendations and suggestions made by the international festival commission.

#### VI. EVALUATION OF FESTIVAL PARTICIPANTS

7. The performances of the festival will be evaluated by an international jury of five directors;
- 7.1. During evaluation the attention will be paid to the disclosure of the program's topic, innovation, directing decision, acting mastery, stage culture, duration, number of disabled participants;
- 7.2 Each team will be evaluated on a 25-point scale according to each evaluation criteria of the competition;
- 7.3 Festival participants will be awarded special prizes, diplomas and commemorative gifts.
